In 1989 I established Stehly Grove Management which currently manages over 250 acres of avocados, mostly organic. I have served my community as a founding director of the Valley Center Fire Protection District, a past president of the Valley Center Rotary Club and Chair of the Palomar Pomerado Health Foundation. In addition to community service I have been involved in both governmental working groups and agricultural organizations on behalf of local farmers. For over 35 years I have served as a director of Corona College Heights Orange and Lemon Association, a citrus packing house. I have been a board member of the San Diego County Farm Bureau for over 25 years and served as its President from 1998 – 2000. I served on the California Farm Bureau Board of Directors from 2018-2024 as well as some of its state committees. I have represented California agriculture on behalf of San Diego and California growers in both Sacramento and Washington. I believe strongly in the mission of the California Avocado Commission.
