I own and manage a 12 acre grove with 1,200 Haas avocado trees in Valley Center (District 1) since I moved here from Colorado 3 years ago. Our production in 2024 was approximately 80,000 lbs. Since taking ownership of the grove, we have performed many upgrades, tasks and projects; mapped the grove, cleared additional acreage, planted more than 100 new trees, hired workers and worked with multiple packhouses and pickers to harvest the fruit. My wife Barri and I do most of the work, hiring workers and services as needed. I have been a member in good standing with the AGC (Avocado Growers of Calif) and CFB (Calif Farm Bureau) for several years. We have also applied for certain grants and secured funding so we are familiar with that process as well.
I have no affiliations with industry packhouses, grove management companies, etc. that could create a conflict of interest. As such, I am more focused on the actual challenges Avocado growers face in California.
